## **Values**

### **Ambitious**

We are not afraid to shape, challenge and tackle the big issues, to take the initiative and pave the way.

#### **Inclusive**

We make UWE Bristol a supportive and inspiring place to learn and work – somewhere where diversity of experience and perspective is encouraged, and learning and research is shared and accessible.

### **Innovative**

We create new opportunities for the people who work and study with us. We embrace different ideas and pioneer new and sustainable ways of doing things.

## **Collaborative**

We have strong connections locally and globally. We help people and organisations be the best they can, building trust throughout our university community and beyond.

### **Enterprising**

We instil a thirst for new knowledge, its creation and application, empowering our students and staff to demonstrate a creative questioning approach, a 'can-do' confidence, and ability to navigate uncertainty.

# Transforming Futures Climate Action and Sustainability Strategy

Through our Strategy 2030, the University aims to transform futures – shaping the health and sustainability of our communities and creating solutions to global challenges.

UWE Bristol recognises the critical global challenges posed by the climate and ecological emergency and wider issues of sustainability. These include the impact that global warming has had, and continues to have, on our environments and society and the rates of change in natural environments, unprecedented in human history.

We recognise the need to further strengthen our commitment and action across the whole university community, both students and staff and with our partner organisations and communities. Through our Strategy 2030 we have defined ambitious performance measures and sector-leading targets. We will also aim, through all our actions and activities to work towards delivering against the United Nations Sustainable Development Goals (see annex one).



# 2.1 Strategic priorities

Through our Transforming Futures Climate Action and Sustainability Strategy our strategic priorities are to:

**Practice Sustainability:** in the operation of our campuses and facilities, student residences, travel and mobililty, procurement and supply chains, energy and waste management, both to reduce impacts and to mitigate and adapt to their effects.

Promote the Understanding of Sustainability: through teaching and learning to equip successive generations of students with the knowledge and commitment to address the ongoing challenges of sustainability and through research aimed at understanding and contributing to addressing these challenges.

Influence Sustainability: working with partners, stakeholders and communities both locally through civic and public engagement, nationally and globally to share knowledge shape and build understanding of the threats and challenges and promote collective solutions.

In order to achieve these goals we will align with our values as set out in Strategy 2030. We will need to be ambitious, innovative and enterprising. We will also need to be collaborative and inclusive in our ways of working.



# 2.2 How we will measure our progress

Through our practice, promotion and influence, we will drive forward our key commitments as set out in Strategy 2030, along with the related performance measures and targets. We will:

| Support research that addresses issues relating to climate change, environmental challenges and biodiversity.  | Number and percentage of internally and externally-funded projects that address climate and environmental issues and which map onto the UN Sustainable Development Goals. |

Action plans for each of these seven commitments set out how our University community will deliver the change required, in line with our Transforming Futures Climate Action and Sustainability priorities. Our approach will also be based on the operating principles on the following page.

# 2.3 Operating principles

- We will be ambitious in our aims and provide leadership in addressing the sustainability challenges.
- In our institutional actions, we will develop an integrated, whole organisational approach.
- We will normalise sustainability in staff and student behaviours and in the mechanisms of university business. Our approach to sustainability will be guided by science and objective evidence. It will be developed within a social justice framework with inclusivity at its heart.
- We will pursue a devolved responsibility model whereby all faculties, professional services and individuals, in their professional and private lives, are empowered and inspired to make sustainable choices.
- We will work in partnership with The Students' Union at UWE Bristol, with city-region agencies and with national bodies.

- We will frame our actions within the context of the United Nations Sustainable Development Goals.
- We will ensure that all UWE Bristol departments understand their sustainability obligations, impacts and opportunities and that appropriate actions are incorporated into annual service and financial planning cycles.
- We will devise new ways of delivering sustainable teaching, research and estates operations.
- We will use our procurement processes and purchasing power to influence our supply chain, through local and ethical procurement, and will work with our suppliers to encourage the highest standards of sustainability performance.
- We will share our knowledge, successes, failures and accumulated expertise on the journey to sustainability.


