and ramp access in to the building. Plans also include widening door ways and creating
changing rooms facilities that are wheelchair user friendly.

Increase in participation by a variety of methods;

- Women in Sport (semi private facility which may encourage higher usage from females)
- Inclusion sport (race, disability and faith)
- Annual booking and user profile which can be shared with other departments in the University.
- Wheelchair sport on the basketball recreation area to provide individuals with more opportunities.

The centre for sport is incredibly busy during the academic year with student union sport teams, timetabled lessons and centre for sport lead activities.

The addition of the walled garden 3G pitch will ensure we can cater for more student groups including faith group sport teams and leagues. A 3G pitch is a surface created using synthetic fibres and rubbers made to look like grass. Unlike sand based artificial pitches the surface does not causefriction burns and is playable in more conditions.

A taught rebound fence and rebound boards will be put in place to protect the wall and this will be set back from the existing wall. The pitch touchlines will be away from the fence to ensure that play does not go directly against the wall. We will also be using existing post holes so that we do not disturb the wall to much whislt installing the new fence.

The area will have a basketball hoop and a suitable surface for wheelchair users. The centre for sport has also recently purchased sport wheelchairs which will be made available to use in this area. The student calendar has a variety of events and we expect to use the area for feel good February, LGBT month and many more activities.

The centre for sport has a sophisticated booking system and we will be able to use this system to provide data for the University to show which groups are using the area, how often and how many participants were at each session.

A small car park is available next to the pitch and has two disabled spaces which will be available to all users. There are also other car parks within walking distance for all to use.

We have spoken to the student union, who have discussed recreational sport on campus with student groups. It has been highlighted from sport strategy meeting groups with students and staff that more recreational sport facilities are needed on campus. This facility will deliver more facilities and we have consulted with the SU on design and the use of the space.

We are providing accessible sport facilities for all. Work is also needed to increase accessible changing facilities and widen door ways for disabled users which we are also progressing as a separate project. This scheme greatly improves the area and there are no foreseeable detrimental effects as the works have been carefully designed to have no negative impact.
