



Module Changes relating to Paid Placements 2021

Dear Students

In light of the most recent impact of the global pandemic on your nursing studies, we have reviewed the programme structure for your final year; we are looking to provide a balance of allowing more time for theory/submissions where possible, without delaying when you can complete.

Please find below a summary of the changes; the global pandemic is affecting all of you, it is impossible to measure the extent it is impacting on individuals and it is not possible to assume those not undertaking paid placements are not affected; therefore, where possible some additional time is being applied to all as an inclusive approach, other modules will have a submission date dependent on whether you are undertaking a paid placement.

Sept 18 Cohorts – all fields

Dissertation – all students

Submission date will now be one week later to 28th April 2021 (14.00); Marks release on 27th May 2021.

Promoting recovery in Mental Health – MH students

Teaching for this module has been completed. Submission date will now be one week later on 11th March 2021 (14.00); Marks release on 13th April 2021.

Leadership in Adult Nursing/Leadership in Childrens Nursing/Leadership in Learning Disabilities Nursing – Adult, Child, LD students

For those not commencing on paid placement, submission dates will remain as planned.

*For those commencing paid placement; module delivery will cease for you on 29th January 2021 and paid placement will commence on 1st February 2021. We will timetable a refresh session and the outstanding sessions on the week commencing 3rd May 2021. Submission will be moved to 25th May 2021 (14.00). **NB** Please do not be concerned if a NS shows on your record, this is a known short-term effect of managing two submission dates - it will be rectified in due course but may not be possible prior to the submission date for those not on paid placement.*

For any student not passing/not submitting at the sit there will be an automatic uncapped resubmission opportunity for theory modules. Whilst the course of the pandemic is unknown, the dates for resubmissions is not going to be confirmed. These will be released as soon as possible but we wish to ensure that resubmission dates are appropriate and therefore need to consider this in

terms of the facilitating you to succeed (having enough time and support) and not delaying completion of the programme unnecessarily.
