- (ii) That the Concordat requires the University to produce an annual statement on research integrity and that the report outlined relevant actions undertaken and provided assurances that processes are robust.
- (iii) That the report confirmed there have been no formal investigations of research misconduct.

The Pro Vice-Chancellor Research and Enterprise confirmed they would investigate the lack of specific reference to the Faculties of Business and

### AB.21.12.5.2 Strategic Research Risk

- The Pro Vice-Chancellor Research and Enterprise presented the paper and members heard:
  - (i) That the risk descriptor was an *opportunity* risk descriptor, identifying the opportunities that need to be realised;
  - (ii) That the overall opportunity is to "enhance academic character and reputation of the University through research in line with Strategy 2030, through expansion of research income and intensity";
  - (iii) That there are six opportunities highlighted in the risk descriptor and red text indicates new actions or issues;
  - (iv) That the risk appetite indicates the risk of investing to grow research;
  - (v) That there are good chances to secure and enhance opportunities for investing in research, aligning to Strategy 2030.
