Student Evaluation User Guide

- 1. Students should access the evaluation form via **ARC POW-NET**. The URL is https://arcpow.uwe.ac.uk/powlive/uweLivepow.dll
- 2. All students must **sign-in**, using their Login Name (your UWE student number) and password. If you are experiencing trouble logging in, please email, arc.systems@uwe.ac.uk
- 3. The placement evaluation period will run for **4 weeks only.** You will receive an email two weeks before the end of your current placement and then at weekly intervals until this period ends, if you have not completed the evaluation.
- 4. Students are requested to complete an evaluation for **each** placement they have been allocated and attended prior to accessing information on their next allocated placement.
- 5. Once you log in, you will be greeted straight away with the evaluation you need to complete.

They are Yes or No questions with open text form. The evaluation is based on a 4-point scale, from 1 (Strongly Disagree) to 4 (Strongly Agree). You must complete all questions to submit the evaluation.
